RECIPE TIME!

Spicy Pretzels

- 16 oz. bag of small twist pretzels
- 1 cup canola/vegetable oil
- 2 tsp. garlic salt
- 2 tsp. lemon pepper
- 1 tsp. cayenne pepper

Pour the oil and all seasonings into a gallon sized Ziploc bag. Seal and combine. Pour the entire bag of pretzels into the oil/seasoning mixture. Close and gently shake to cover the pretzels – being careful not to break the pretzels into pieces. Lay the bag flat and let the magic begin. The pretzels will gradually soak up the oil and all of the spicy goodness. I flip and gently shake the bag occasionally to get an even coating – being patient and resisting the urge to dive in to try one. The pretzels, in all their spicy glory, will be ready to munch on in 24 hours. They are worth the wait!


